to look after and maintain said road, must, besides keeping the road safe and in good repair, must look after all bridges on the line of said road and keep them in a safe and passable condition, the County to furnish material for same; and that the period for which it is wise and expedient to pay for the repairing and keeping in repair said described road at this time is two years, beginning May 7th 1898 and ending May 7th 1900.

Therefore it is by this Court ordered, that the Clerk of this Court be, and he is hereby ordered and directed to publish in the Pendleton East Oregonian, a weekly newspaper of general circulation in the County of Umatilla, and State of Oregon, for a period of 30 days, beginning March 29th 1898, a notice to the effect that sealed bids for the maintaining and keeping in repair said above described road for the period of two (2) years in accordance with the terms of this order, said bids will be received at the office of said Clerk at the Court House in the city of Pendleton in said County and State, until the hour of 4 o'clock in the afternoon of Wednesday, May 4th, 1898. The person receiving the contract to enter into an agreement with the County of Umatilla, to hold said County of Umatilla harmless from any and all liability by reason of any accident occurring on said road during the term of said contract; bids to be accompanied by an undertaking with two or more sureties in the sum of \$1,000, conditioned to perform all the several terms of the contract, which contract shall embody the terms, requirements and agreements of said order of Court.
