WHEREAS, the Umatilla County Board of Commissioners may, under authority of ORS 368.201 to 368.221, order a county road that has been used and traveled by the public for ten (10) years or more to be surveyed, and

WHEREAS, the Umatilla County Board of Commissioners ordered the survey of that portion of Goad Road (County Road No. 987) described as follows:

A strip of land for road purposes lying in Section 13, Township 2 North, Range 32 East W. M. and Sections 18 and 19, Township 2 North, Range 33 East W. M., being 60 feet in width and lying 30 feet on each side of the following described centerline:

Commencing at a brass-capped monument marking the Northeast Corner of Section 13, Township 2 North, Range 32 E.W.M.; thence South 00 Degrees 00 Minutes 38 Seconds West, 1783.95 feet along the east line of the Northeast ¼ of Section 13 to a 5/8-inch iron pin and the true point of beginning of this description; thence South 15 Degrees 46 Minutes 41 Seconds East, 83.55 feet; thence 99.87 feet along an 809.75-foot radius curve right (the long chord bears South 12 Degrees 14 Minutes 40 Seconds East, 99.81 feet); thence South 08 Degrees 42 Minutes 40 Seconds East, 426.93 feet; thence 157.05 feet along a 260.05-foot radius curve right (the long chord bears South 08 Degrees 35 Minutes 24 Seconds West, 154.67 feet); thence South 25 Degrees 53 Minutes 28 Seconds West, 122.78 feet; thence 143.49 feet along a 316.47-foot radius curve left (the long chord bears South 12 Degrees 54 Minutes 07 Seconds West, 142.26 feet); thence South 00 Degrees 05 Minutes 14 Seconds East, 2495.12 feet along the East Line of the Southeast ¼ of Section 13 to a brass-capped monument marking the Southeast Corner of Section 13 and there terminating.

WHEREAS, the Notice of Hearing was posted and all owners of abutting property affected by the legalization procedure were served copies of the Notice of Hearing, and

WHEREAS, the Umatilla County Board of Commissioners on April 2, 1997, held a public hearing and received no objections to the legalization:

THEREFORE IT IS NOW ORDERED that the survey of Goad Road, County Road No. 987, be recorded by the County Surveyor, and that the road be legalized as described above.
