RESOLUTION

IT APPEARING to the Umatilla County Board of Commissioners that the Franklin Grade Road,

an extension of S. E. 10th. Street in the City of Pendleton, will constitute access to and from the

Northeastern Oregon Regional Youth Center and is primarily an unimproved road, and

WHEREAS it appears that traffic will increase substantially, due to the construction of the

Youth Center, and

WHEREAS the improvement of Franklin Grade would make access to and from the Youth Center

safer and therefore, under these circumstances, a public necessity exists, now therefore

IT IS THE INTENTION by this Resolution of the Board of County Commissioners for Umatilla

County:

- To create a County Road sixty (60) feet in width to be known as County Road #371 (Franklin Grade), and
- 2. A legal description of the proposed road is as follows:

Commencing at the Intersection of the Center line of S. E. Frazer Avenue and S. E. 10th. Street in the City of Pendleton; thence S 23° 36' 30" E. 380.00 feet; thence on 12.1341° curve left 313.33 feet; thence S 61° 37' 42" E. 443.87 feet; thence on a 14.3240° curve left 284.86 feet; thence N 77° 34' 06" E. 452.13 feet; thence on a 18.8331° curve right 418.54 feet; thence S 23° 36' 30" E. 120.03 feet; to the Intersection of Center line of S. E. 15th. Street and the South Boundary of Reservation Addition to the City of Pendleton; thence S 23° 36' 30" E. 820.0 feet to Center $\frac{1}{4}$ section line, Section 11, Township 2 North, Range 32 East, W. M.; thence Easterly on Center $\frac{1}{4}$ section line 530 feet to $\frac{1}{4}$ corner common to Sections 11 & 12, Township 2 North, Range 32 East, W.M.; thence Easterly on Center $\frac{1}{4}$ section line, through Section 12, 2695.00 feet to Center of Section 12, Township 2 North, Range 32 East, W.M.

IT IS THEREFORE ORDERED:

 That notice be given by mailing true copies of this Resolution by certified mail, with return receipt requested, to all affected and adjacent property owners, and

- 2. That true copies of this Resolution will be posted on the bulletin board at the County Courthouse, the City Hall and three (3) places in the vicinity of the proposed road, and
- 3. Directing a public hearing to be held in Room 114 in the Umatilla County Courthouse, Pendleton, Oregon, at 10:00 o'clock a.m., on the 5 day of <u>tele</u>, 1975, at which time the Board of County Commissioners will receive testimony both for and against this Resolution.
