## PARCEL NO. 1

A parcel of land lying in the South half of the Northwest quarter  $(S_2^1 NW_4^1)$ and the Southwest quarter  $(SW_2^1)$  of Section 3, Township 1 South, Range 35 East, W.M., Usatilla County, Oregon; the said parcel being that portion of said subdivisions included in a strip of land 300 feet in width, 150 feet on each side of the center line of the Old Oregon Trail Highway as said highway has been relocated, which center line is described as follows:
