Dear Mr. Nelson:

The Umatilla County Board of Commissioners desires to transfer jurisdiction of County Road Number 1075 (Tutuilla Road) and County Road Number 1310 (S.W. Dorian Extension) to the City of Pendleton.

As referenced in your letter dated April 19, 1988, the transfer of County Road Number 1075 (Tutuilla Road) to the City of Pendleton, is for that section of road that lies between the intersection with U.S. Highway 395 and Athens Avenue.

The County Road Number 1310 (S.W. Dorian Extension) transfer, is for that section which lies between S.W. 20 Street and S.W.23 Street, as is noted in the Agreement between Umatilla County and the Oregon Department of Transportation, Highway Division, dated March 8, 1966, which is shown on the accompanying drawing (highlighted in pink.)

Re: 'Transfer of County Roads to City Jurisdiction

Dear Jon:

The purpose of this letter is to memorialize the meeting held between City Public Works Staff, City Attorney, yourself, County Road Department Staff, Commissioner Bill Hansell, and myself, on January 10, 1990, to discuss the feasibility of transferring certain county roads to City jurisdiction.

At this meeting, it was agreed that portions of Tutuilla and Dorion Extension currently under consideration of the public hearing process of the county should continue to completion and offered to the City for acceptance. In addition, it was understood that Patawa, Quinney, and a portion of 44th Street will be considered for acceptance by the City once they are brought up to City standards. The County and City Public Works Staff shall continue to review these streets, and once they are brought up to City standards, a new public hearing process will be begun for transfer to the City.

If this letter does not comport with your understanding of the meeting and the agreement between the County and the City, please let me know as soon as possible.

RECOMMENDATION:

That the Mayor and City Council adopt Resolution No. 1622 authorizing the City of Pendleton to:

- 1. Accept the transfer of jurisdiction from Umatilla County for County Road No. 1075, Tutuilla Road beginning at its intersection with Highway 395 to the northerly right-of-way of Athens Avenue; and
- 2. Accept the transfer of jurisdiction from Umatilla County for County Road No. 1310, S. W. Dorion Extension from S. W. 20th to the Easterly rightof-way line on S. W. 23rd.

DISCUSSION:

ORS 373.270 allows transfer from counties to cities over jurisdiction of a county road within a city. There is a specific process which the county must follow to accomplish that transfer. The County has followed the statutory procedures set forth in ORS 373.270.

The next step in the process is for the City Council to decide whether or not they will accept the transfer of jurisdiction. Staff has reviewed the letter dated January 10, 1990, from the Umatilla County Commissioners to the City Manager. A copy of that letter is attached.

Staff met with Mr. Hansell, County Commissioner; members of the Umatilla County road crew; and their county counsel to discuss the matter further. As the Council is aware both of the above referenced roads have been improved to City standards.

Staff recommends that the above two (2) roads which now meet City standards and are within the City of Pendleton be transferred from Umatilla County's jurisdiction to the City's.

RESOLUTION NO. 1622

WHEREAS, the Umatilla County Board of Commissioners by letter dated January 10, 1990, a copy of which is attached hereto as Exhibit "A" desire to transfer jurisdiction of County Road No. 1075, Tutuilla Road, from its intersection with Highway 395 to the northerly right-of-way of Athens Avenue; and

WHEREAS, the Umatilla County Board of Commissioners by letter dated January 10, 1990, a copy of which is attached hereto as Exhibit "A" desire to transfer jurisdiction of County Road No. 1310, S. W. Dorion Extension, from S. W. 20th to the Easterly right-of-way line of S. W. 23rd; and

WHEREAS, the Umatilla County Board of Commissioners have followed the legal procedures set forth in Oregon law for transfer of the above referenced roads from jurisdiction of Umatilla County to the City of Pendleton; and

WHEREAS, the above described roads are now built to a standard acceptable to the City of Pendleton; and

WHEREAS, the City Council has reviewed the above request from the Board of Commissioners of Umatilla County requesting that they surrender jurisdiction to the City of Pendleton; and

WHEREAS, the City of Pendleton intends and does by this resolution accept the offer to have jurisdiction over the above County Roads transferred to the City of Pendleton effective March 1, 1990.

NOW THEREFORE BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF PENDLETON:

THAT effective March 1, 1990, the jurisdiction of Umatilla County over County Road No. 1075, Tutuilla Road, from its intersection with Highway 395 to the northerly right-of-way of Athens Avenue, as a County road for its improvement, construction, or repair shall cease, and further that the full and absolute jurisdiction over the road for all purposes of repair, construction, improvement and the levying and collection of assessments therefore shall vest with the City of Pendleton.

BE IT FURTHER RESOLVED THAT effective March 1, 1990, the jurisdiction of Umatilla County over County Road No. 1310, S. W. Dorion Extension, from its intersection with S. W. 20th to the Easterly right-of-way of S. W. 23rd as a County road for its improvement, construction or repair shall cease, and further that the full and absolute jurisdiction over this road for all purposes of repair, construction, improvement and the levying and collection of assessments therefore shall vest in the City of Pendleton.

Page 1 - Resolution No. 1622 (900216)

BE IT FURTHER RESOLVED THAT the City of Pendleton shall have the same jurisdiction over the above roads or portion thereof as by its charter and the laws of the State are given or granted it over any of the other public streets and alleys of the City of Pendleton.
