D. R. Cook, County Judge, and J. E. Olinger and Roscoe H. Kelley, County Commissioners, the following proceedings were had:

<u>Whereas</u>, by resolution and order unanimously adopted on the <u>1844</u> day of <u>mump</u>, 195<u>6</u>, it was declared that proceedings to vacate those portions of County Road <u>95</u> hereinafter described, would be undertaken, and said proceedings were instituted, and the County Engineer was notified of said proceedings and was ordered and directed to examine said portions of County Road <u>95</u> and to make a report in writing on the same as provided by law; and

<u>Whereas</u>, said County Engineer did examine said portion of County Road <u>715</u>, and on the <u>Maday of Jebnus</u>, 195<u>6</u>, made his report in writing thereon as required by law, and filed said report with the County Clerk of Umatilla County, Oregon, and

<u>Whereas</u>, said notice of hearing was duly given by posting as required by law on the <u>day</u> of <u>Hebrury</u>, 195<u>6</u>, which was more than thirty days before the day set for said hearing; and proof that such notice has been given was made by affadavit of the County Engineer, now on

file herein; and,

<u>Whereas</u>, pursuant to said order and notice this matter came on duly to be heard by the County Court of Umatilla County, Oregon in the Courtroom of said Court in the Temporary Umatilla County Courthouse at Pendleton, Oregon on the <u>1446</u> day of <u>Monch</u>, 1956, at 10:00 o'clock, A. M., at which time and place the said report of the County Engineer was duly heard and considered, and the said resolution instituting said proceeding was duly considered and no objection was made by any per= son to the vacation of said portion of County Road <u># 915</u> and,

<u>Whereas</u>, it appears to this Court that said portions of County Road # <u>9.5</u> are not now in use by the public, and that they will not be a useful part of the general road system of Umatilla County, Oregon, and it further appears that the public will be benefited by the vacation there= of; and the Court being fully advised in the premises;

It Is Hereby Ordered that the following described portions of County Road #_____ of Umatilla County, Oregon, described as follows, to wit;

Beginning at a point on the Northeasterly line of County Road 915 at its intersection with the North-South centerline of Section 15, Township 2 North, Range 32 East of Willamette Meridian, and running thence North 332 feet more or less to the point where the old location of Baid road curved in a Northwesterly direction away from the said North-South centerline, excluding therefrom, all portions which remain on the existing paved road right-of-way, and

be and the same are hereby vacated.
