A strip of land sixty feet wide being thirty feet wide on each side of the center line of the Yoakum-Stage Gulch Market Road as surveyed over and across the Northeast Quarter of Sec. 2, Twp. 2 N. of Rg. 30 E.W.M. The above mentioned center line being more particularly descirbed as follows:
