have granted, bargained, sold and conveyed, and by these presents do.....grant, bargain, sell and con-
vey unto the County of Umatilla, State of Oregon, the following described parcel of land, situate in
Umatilla County, State of Oregon, to-wit: A strip of ground 60 feet wide for road
purposes over and across the west $\frac{1}{2}$ of the NW $\frac{1}{4}$ of Section 16 and the
NW corner of the NW $\frac{1}{4}$ of the SW $\frac{1}{4}$ of Section 16 Twp. 3 N.R. 30 E.W.M.The center line being more particularly described as beginning at a
point 844 feet East of the NW corner of section 16 said Twp. and Range the
line S 15° 34' W. a distance of 2882.0 feet thence around a 37° curve
(the long cord of which bears S5° 42' E.) a distance of 115.9 feet thence
S 27° 19' E. a distance of 230 feet more or less to a point on the North
right of way line of the Pendleton-Stanfield Highway, said point being
S. 78° 45' East of and distant 220 feet more or less from engineers
station 593 + 61.2. All located in Section 16 Twp. 3 N. R. 30 E.W.M.
