Whereas, by resolution and order unanimously adopted on the May of July, 1955, it was declared that proceedings to vacate those portions of County Road 82 hereinafter described, would be undertaken, and said proceedings were instituted, and the County Roadmaster was notified of said proceedings and was ordered and directed to examine said portions of County Road 82 and to make a report in writing on the same as provided by law; and

Whereas, said County Roadmaster did examine said portions of County Road 82, and on the 13 day of July, 1955, made his report in writing thereon as required by law, and filed said report with the County Clerk of Umatilla County, Oregon, and

Whereas, said notice of hearing was duly given by posting as required by law on the 3^{-4} day of 2aly 1955, which was more than thirty days before the day set for said hearing; and proof that such notice has been given was made by affadavit of the County

Roadmaster, now on file herein; and,

<u>Whereas</u>, pursuant to said order and notice this matter came on duly to be heard by the County Court of Umatilla County, Oregon, in the Courtroom of said Court in the Temporary Umatilla County Court house at Pendleton, Oregon, on the <u>3/4</u> day of <u>august</u>, 1955, at 10:00 o'clock, A.M., at which time and place the said report of the County Roadmaster was duly heard and considered, and the said resolution instituting said proceeding was duly considered and no objection was made by any person to the vacation of said portions of County Road 82, and

Whereas, it appears to this Court that said portions of County Road 82 are not now in use by the public, and that they will not be a useful part of the general road system of Umatilla County, Oregon, and it further appears that the public will be benefited by the vacation thereof; and the Court being fully advised in the premises;

It Is Hereby Ordered that the following described portions of County Road 82 of Umatilla County, Oregon, described as follows, to wit:

All portions of the reconstructed and relocated foregoing described portions shall have a right-of way width of 60 feet.
