WHEREAS, it is desired by the Umatilla County Court and the Umatilla County Road Department to establish and/or legalize by prescribed proceedings under O.R.S. 368.405, par. (1) & sub par. (c); A COUNTY ROAD and the said road to 60 feet wide of which <u>CENTER LINE</u> is described as follows; to wit:
