WHEREAS, pursuant to ORS 368.341, the Umatilla County Board of Commissioners received and accepted a petition from owners of 100 percent of the abutting property, to initiate proceedings to vacate the northerly 16 feet of a portion of Feedville Road, County Road No. 1180 (a.k.a. County Road No. 608), located in the Southwest Quarter of the Southwest Quarter of Section 20, Township 4 North, Range 28, East of the Willamette Meridian; and

WHEREAS, pursuant to ORS 368.346, the Board of Commissioners directed the Public Works Director to prepare and file a written report including a recommendation as to whether the vacation would be in the public interest; and

WHEREAS the Director of Public Works, after reviewing the proposed action, has recommended that the road be vacated; and

WHEREAS ORS 368.351 allows a county governing body to vacate public property without holding a public hearing if the petition to vacate contains signatures of 100 percent of owners of property abutting a proposed vacation.

NOW THEREFORE, the Board of Commissioners orders that:

1. That portion of Feedville Road, County Road No. 1180 (a.k.a. County Road No. 608) described as follows is vacated:

A strip of land within the right-of-way limits of Feedville Road, County Road No. 1180 (a. k. a. County Road No. 608) located in Section 20, Township 4 North, Range 28, East of the Willamette Meridian, Umatilla County, Oregon, being more particularly described as commencing at a brass-capped monument marking the corner common to Sections 19, 20, 29, and 30, Township 4 North, Range 28, E. W. M.; thence North 00°48'50" West 17.00 feet along the line between Sections 19 and 20 to a 5/8-inch iron rebar and the true point of beginning; thence continuing along said section line North 00°48'50"
