## **BARGAIN AND SALE DEED**

RECORDS Monte and Danny Mills, Grantors, convey to Umatilla County, a political subdivision of the State of Oregon, Grantee, the following described real property:

A parcel of land for road purposes located in the Northeast ¼ of the Southeast ¼ of Section 33, Township 4 North, Range 29 East of the Willamette Meridian and being more particularly described as follows:

Commencing at a 5/8-inch rebar marking the Southeast Corner of the Northeast ¼ of the Southeast ¼ of Section 33, T. 4 N., R. 29 E.W.M.; thence N61°41'41"W, 318.41 feet to a point on the northerly right-of-way line of the USRS Feed Canal, and the true point of beginning of this description; thence S67°30'13"W, 305.63 feet along said northerly canal right-of-way line to its intersection with the northerly right-of-way line of County Road #1184; thence 27.06 feet along a 92.23-foot radius curve left on said northerly road right-of-way line (the long chord bears N86°43'40"W, 26.96 feet); thence N63°14'34"E, 64.86 feet; thence N68°39'23"E, 108.44 feet; thence N72°44'08"E, 157.47 feet to the point of beginning. The above described parcel is located in Umatilla County and contains 0.082 acre, more or less.
