ORDER NO. 97-03

**WHEREAS,** the Umatilla County Board of Commissioners may, under authority of ORS 368.201 to 368.221, order a county road that has been used and traveled by the public for ten (10) years or more to be surveyed and recorded, and

**WHEREAS,** the Umatilla County Board of Commissioners ordered the survey of that portion of Bartley Road (County Road No. 1184) described as follows:

A strip of land for road purposes located in the Southeast ¼ of Section 33, Township 4 North, Range 29 East W. M., being 40 feet in width and lying 20 feet on each side of the following described centerline:

Beginning at a 5/8-inch iron pin marking the Southeast 1/16<sup>th</sup> Corner of Section 33, Township 4 North, Range 29 E.W.M.; thence South 89 Degrees 14 Minutes 00 Seconds East, 531.50 feet; thence 79.48 feet along a 284.61-foot radius curve left (the long chord bears North 82 Degrees 46 Minutes 00 Seconds East, 79.22 feet); thence North 74 Degrees 46 Minutes 00 Seconds East, 104.00 feet; thence 55.15 feet along a 72.23-foot radius curve right (the long chord bears South 83 Degrees 21 Minutes 30 Seconds East, 53.82 feet; thence South 61 Degrees 29 Minutes 00 Seconds East, 52.00 feet; thence 58.39 feet along a 103.37-foot radius curve left (the long chord bears South 77 Degrees 40 Minutes 01 Second East, 57.62 feet); thence North 86 Degrees 08 Minutes 59 Seconds East, 445.92 feet to a 5/8-inch iron pin marking the South 1/16<sup>th</sup> Corner common to Sections 33 and 34, Township 4 North, Range 29 E.W.M. and there terminating.

**WHEREAS,** the Notice of Hearing was posted and all owners of abutting property affected by the legalization procedure were served copies of the Notice of Hearing, and

**WHEREAS,** the Umatilla County Board of Commissioners on January 23, 1997, held a public hearing and received no objections to the legalization:

**THEREFORE IT IS NOW ORDERED** that the survey of Bartley Road, County Road No. 1184, be recorded by the County Surveyor, and that the road be legalized as described above.
