Report on Vacation of a Portion of Bloom Road, County Road No. 1192

History

Bloom Road is a portion of old County Road No. 651 that was established in 1908. Road 651 also makes up portions of Agnew, Walker, Westland, and Colonel Jordan Roads as can be seen on the old survey plat which is attached. The portion of Bloom Road affected by this vacation proceeding is that portion lying between Westland Road and Walker Road. This portion of the road has never been constructed as can be seen on the attached photographs.

Issue

The Lamb Road/Walker Road/Westland Road intersection is scheduled to be re-built in 2012. In order to connect Walker Road with Westland Road per the new intersection plan, additional right of way will be needed across Tax Lots 2900 and 2904. Terra Poma Land, owner of Tax Lot 2904, has agreed to deed Umatilla County their portion of the new right of way in return for the County vacating this portion of the Bloom Road right of way which runs across the north line of their property.

Impacts to Utilities

No adverse impacts to utility companies are anticipated.

Recommendation

The new intersection is needed from a public safety standpoint. Vacation of the road will allow necessary right of way acquisition without any out - of - pocket expense to the County and basically amounts to a land swap. The Public Works Department recommends that the road be vacated.
