ADDENDUM TO CONTRACT OF SALE

Legal Description: Erz Property

Beginning at Section corner common to Sections 5, 6, 7 and 8, Township 4 North, Range 29; thence South along East line of said Section 7, a distance of 133 feet to North right of way line of 0. W. R. N. & Co., right of way; thence South 56° 10' West along said right of way a distance of 4940 feet to Southeast corner of tract of land conveyed to Robert 0. Behrman, by Deed recorded in Book 268, Page 447, Deed Records; thence North along East line of said Behrman Tract a distance of 730 feet to Northeast corner thereof, said point also being the intersection with South right of way boundary of "A" Line Canal of Hermiston Irrigation District; thence in a generally Northeasterly direction along said South right of way to an intersection with North boundary line of said Section 7; thence East along North line of said Section 7, a distance of 553.5 feet to Northeast corner of said Section 7 and the point of beginning;

All being East of the Willamette Meridian, Umatilla County, Oregon; SUBJECT to any and all water rights of way and roads.
