IT APPEARING that on August 7, 1991, pursuant to ORS 368.341, the Board of Commissioners accepted and referred to the Director of Public Works for investigation a petition initiating proceedings to vacate said road; and

APPEARING that the Director of Public Works, after IT reviewing the petition and coordinating with utility companies, has recommended that the said portion of road and easement, be vacated; and

IT FURTHER APPEARING that subsequent to acceptance of the petition on August 7, 1991, in the hearing room of the Board of Commissioners in the Umatilla County Courthouse, Pendleton, Oregon; as 100% of the landowners signed the petition, notice of the time and place of the hearing was not needed, as provided by law; and finding the property proposed for vacation to have little to no value to the county, no liabilities are to be incurred resulting from the vacation; and the Board of Commissioners finding that it would be in the public interest to vacate said portion of County Road and easement, Section 4, Township 4 North, Range 28 East, W.M. approximately 1.5 miles North of the city of Hermiston, Umatilla County, Oregon hereinafter described; (Legal description attached by this reference incorporated herein.)

The county surveyor is directed to mark the plat as provided.
