WHEREAS, in accordance with ORS 373.270(1)(a) the Umatilla County Board of Commissioners has determined it to be in the best interest of the County to transfer jurisdiction of that portion of County Road No. 1238, West Orchard Avenue, lying in the East ½ of the Southeast ¼ of Section 9, T. 4 North, Range 28 E.W.M. between the northerly extension of the west boundary of Viewcrest Addition and the westerly right-of-way line of State Highway No. 207, near the West City Limits of Hermiston, Oregon, and

WHEREAS, the City of Hermiston has agreed to accept jurisdiction of the above described portion of road once the road was improved to meet the conditions set forth in the Supplemental Development Agreement for Viewcrest Addition between the City, County, and Developer, and

WHEREAS, the road improvements have been completed in accordance with the Agreement:

NOW THEREFORE IT IS HEREBY ORDERED that a hearing is set for <u>December 20</u>, 1999, at <u>10:00 a.m.</u> in Room 121 of the Umatilla County Courthouse, 216 S.E. Fourth Street, Pendleton, Oregon to hear public testimony both for and against the proposed jurisdiction transfer and determine if the above described portion of West Orchard Avenue shall be transferred to the City of Hermiston, Oregon.

IT IS ALSO ORDERED that in accordance with ORS 373.270(2)(a) notice of the hearing shall be posted in 3 public places, one of which shall be within the city limits of Hermiston, Oregon.
