WHEREAS, pursuant to ORS 373.270(2)(a), (2)(b), and (3) notice of a public hearing was posted and published, and

WHEREAS, pursuant to ORS 373.270(4) a hearing was held on August 5, 1998, at 10:15 a.m. to hear public testimony both for and against the proposed transfer, and determining it to be in the public interest to transfer the above described portion of East Elm Avenue to the City of Hermiston:

IT IS HEREBY ORDERED that in accordance with ORS 373.270(6)(b) jurisdiction of the above described portion of County Road No. 1240 (East Elm Avenue) be transferred to the City of Hermiston, Oregon, and that improvement, construction, or repair by the County shall cease, and that the full and absolute jurisdiction over the road for all purposes of repair, construction, improvement, and the levying and collection of assessments shall vest in the City.
