East Elm Avenue/West Elm Avenue/11th Street Transfer to the City of Hermiston

Resolution No. 1508 was passed by the City Council of Hermiston in May, 1998, requesting that the Umatilla County Board of Commissioners initiate proceedings to transfer jurisdiction over Elm Avenue between N.W. 11th Street and Diagonal Road (State Highway No. 207) and over N.W. 11th Street between West Elm Avenue and West Hermiston Avenue to the City. A copy of the Resolution is attached.

In 1991, the portion of East Elm from Highway 395 to N.E. 4th Street was transferred to the City; in 1995 the portion of West Elm from Highway 395 to River Road and the portion of N.W. 11th Street from just north of Linda Avenue south to Hermiston Avenue were transferred to the City. Copies of the orders and other correspondence are included in this report.

The last page of this report is a map showing current road ownerships. Roads highlighted in red are former County Roads previously transferred to the City. Roads highlighted in purple are State Highways. Roads highlighted in yellow are County Roads. The roads shown in green and yellow are the County Roads that the City has requested the transfer of jurisdiction over.

The truck route is currently on Elm Avenue from Highway 207 west across Highway 395 and River Road to 11th Street, then south to Hermiston Avenue (Highway 207). Future plans are to leave the truck route in its present location, but to bring the unimproved portions of Elm Avenue and 11th Street to a standard that will better handle truck traffic. Future plans also include ODOT assuming jurisdiction over the truck route and the City assuming jurisdiction over a portion of Highway 207.

The Public Works Department recommends that jurisdiction of the portions of Elm Avenue and 11th Street described above and in the final orders be transferred to the City of Hermiston.

RESOLUTION NO. 1508

WHEREAS, the Hermiston City Council deems it necessary, expedient and in the best interests of the City of Hermiston to acquire jurisdiction over Elm Avenue between N.W. 11th Street and Diagonal Road and over N.W. 11th Street between W. Elm Avenue and W. Hermiston Avenue to the same extent as it has over other public streets and alleys of the City,

NOW, THEREFORE, the Hermiston City Council does hereby request the Umatilla County Board of Commissioners to initiate a proceeding to transfer jurisdiction over Elm Avenue between N.W. 11th Street and Diagonal Road and over N.W. 11th Street between W. Elm Avenue and W. Hermiston Avenue from Umatilla County to the City of Hermiston in accord with ORS 373.270.

LEGAL DESCRIPTION: Beginning at the North 1/16th Corner common to Sections 9 and 10, Township 4 North, Range 28 E.W.M., said 1/16th Corner also marking the centerline of NW 11th Street; thence S0°20'34"W, 1308.02 feet along the north-south section line common to Sections 9 and 10 to the 1/4 corner common to Sections 9 and 10 which also marks the right-of-way centerline of County Road No. 1247; thence S0°20'00"W, 631.02 feet along the north-south section line common to Sections 9 and 10 to the north-routh section line common to Sections 9 and 10 to the south section line common to Sections 9 and 10 to the northerly right-of-way line of Hermiston Avenue (State Highway 207) and there terminating. Bearings and distances are based on Surveys #84-107-B, #84-102-C, M-14-B, and 84-102-C filed in the Umatilla County Surveyor's Office.
