ORDER NO. RD98-13

WHEREAS, the Umatilla County Board of Commissioners may, under authority of ORS 368.201 through 368.221, order a county road that has been used and traveled by the public for ten (10) years or more to be surveyed, and

WHEREAS, the Umatilla County Board of Commissioners ordered the survey of the portion of Craig Road (County Road #1259) described as follows:

A STRIP OF LAND FOR ROAD PURPOSES LOCATED IN SECTIONS 19, 20, 30, AND 31, TOWNSHIP 5 NORTH, RANGE 29 E.W.M., SAID STRIP OF LAND BEING 66 FEET WIDE AND LYING 33 FEET ON EACH SIDE OF THE FOLLOWING DESCRIBED CENTERLINE:

COMMENCING AT A 2-3/8" BRASS CAP MARKING THE CORNER COMMON TO SECTIONS 17, 18, 19, AND 20, T. 5 N., R. 29 E.W.M.; THENCE S07°07'30"E, 670.87 FEET TO A 5/8" REBAR WITH YELLOW PLASTIC CAP SET ON THE SOUTHERLY RIGHT-OF-WAY LINE OF U.S. HIGHWAY 730 AND THE TRUE POINT OF BEGINNING OF THIS DESCRIPTION; THENCE S06°39'36"W, 655.93 FEET; THENCE 227.40 FEET ALONG A 683.22-FOOT RADIUS CURVE LEFT (THE LONG CHORD BEARS S02°52'31"E, 226.35 FEET); THENCE S12°24'37"E, 285.02 FEET; THENCE 205.48 FEET ALONG A 1798.03-FOOT RADIUS CURVE RIGHT (THE LONG CHORD BEARS S09°08'11"E, 205.37 FEET); THENCE 441.03 FEET ALONG A 3722.27-FOOT RADIUS CURVE RIGHT (THE LONG CHORD BEARS S02°28'05"E, 440.77 FEET); THENCE S00°55'34"W, 112.87 FEET; THENCE 133.60 FEET ALONG A 299.69-FOOT RADIUS CURVE RIGHT (THE LONG CHORD BEARS \$13°41'50"W, 132.50 FEET); THENCE 186.32 FEET ALONG A 417.94-FOOT RADIUS CURVE LEFT (THE LONG CHORD BEARS S13°41'50"W, 184.78 FEET); THENCE S00°55'34"W, 1069.12 FEET; THENCE S00°33'16"W, 1340.75 FEET; THENCE S00°29'15"W, 1293.62 FEET TO A 2" ALUMINUM CAP ON A 5/8" REBAR MARKING THE NORTH 1/16TH CORNER COMMON TO SECTIONS 29 AND 30, T. 5 N., R. 29 E.W.M. AND THE TERMINUS OF THIS DESCRIPTION. THE ABOVE DESCRIBED STRIP OF LAND IS LOCATED IN UMATILLA COUNTY AND CONTAINS 9.02 ACRES, MORE OR LESS.

WHEREAS, the Notice of Hearing was posted and all owners of abutting property affected by the legalization were served copies of the Notice of Hearing, and

WHEREAS, the Umatilla County Board of Commissioners, on September 2, 1998, held a public hearing, and determining it to be in the public interest to legalize the road:
