AND WHEREAS, this being a regular term of the Umatilla County Court and the said Court being now in regular session, sitting for the transaction of County business with all members of said Court present. NOW, THEREFORE, BE IT RESOLVED by the County Court of Umatilla County, State of Oregon, sitting at the

regular monthly term for the month of March 17th, 19.48, in the County Court Room of the Court House, in Pendleton, Umatilla County, State of Oregon, for the transaction of County business, that it is and is hereby declared to be the intention of the said County Court to locate, establish, alter, widen, straighten and change a road or highway on and over a route as follows:

BE IT RESOLVED that the proposed road

shall commence, run and terminate as follows, to-wit: Beginning on the East City Limits of the City of Umatilla on the inter-section of third street, running thence N. 73° 13' E. a distance of 625.2 feet, said portion of the above described road shall be 60 feet in width. Thence continuing N. 73° 13' E. a distance of 870 feet more or less to a point, this portion of the road shall be 70 feet in width. Thence continuing N. 73° 13' E a distance of 2640 feet. This portion of the road shall be 80 feet in width. Thence continuing N. 73° 13' E. a distance of 1004.6 feet more or less to a point on the west line of Tax No. 2 of Section 9, Tp. 5 N.R. 28 E.W.M. This portion of the road last above described shall be 60 feet in width.

The right of way or roadway to be a strip of land feet wide being varying in width from 60 feet to 80 feet

of the above described line.
