In the Matter of County Road, No. 782, Petitioned for by H. Spinning, et al.

Now on this day this matter comes on regularly to be heard upon the report of the County Road Viewers, heretofore instructed by the Court to view, survey and report upo said proposed road No. 782, petitioned for as follows, to-wit: view, survey and report upon

Said proposed road No. /82, petitioned for as follows, to-wit: Commencing at a point at the end of the diagonal road in the center of Section 16, T. 5, NR 28 EWM; thence running north and west about six hundred feet over the brow of the hill; thence running south and west on a grade not to exceed five per cent to the center of Section line between Sections 16 and 17 of the aforesaid township and range; thence running west and north about six hundred feet to the present railroad crossing; thence north on the west side of the railroad to the quarter line of the above mentioned Section 17, parallel with the railroad; thence in a westerly course to the east end of Sixth St., of the City of Unatilla, and there terminating; said road to be sixty feet wi and the same having been publicly read on two different days of the same term of Court; and the Board of County Road Viewers having recommended that said road be established and of wide; and the same having been publicly read on two different days of the same term of Court; and the Board of County Road Viewers having recommended that said road be established and the plat and field notes being on file and the Court being now fully advised in the premises. IT IS THEREFORE CONSIDERED AND ORDERED That said report of the County Road Viewers be approved, and that the road supervisor through whose district said road runs be, and he is hereby ordered to open said road for public use. In the Matter of Vacation of County Road, Petitioned for by H. Spinning, et al.

Now on this day this matter coming on for hearing upon the report of the County Road Viewers, heretofore instructed by the Court to view, survey and report upon said road which is proposed to be vacated, petitioned for as follows: Commencing at a point in the center of Section 16, T. 5, NR 28 EWM, at the end of the diagonal road, thence running west to the center of the section line between Sections 16 and 17 of the above named town-ship and r ange; thence running north to the northwest corner of the southwest quarter of the northwest quarter of Section 16; said road being sixty feet wide; and the same having been publicly read on two different days of the same term of Court, and the said Board of County Road Viewers having reported favorably and recommended that said road be vacated; and the plat and field notes being on file, and the Court being satisfied that said road is not of sufficient public utility. IT IS THEREFORE HEREBY ORDERED That said report of the Board of County Road Viewers be approved and that said road be vacated and that the plat and field notes be recorded in the record of plats and field notes of Umatilla County and that the road supervisor through whose district said road is now established be, and he is hereby ordered and instructed to close the same to public travel. In the Matter of Tax Levy for Forest Fire Patrol fund.

Now on this day this matter coming on for hearing, and it appearing to the Court that the State Forester reports that a tax levy of  $\frac{1}{2}$  cent per more should be levied on timber lands for the forest fire patrol fund and the Court being advised in the premises, IT IS THEREFORE HEREBY ORDERED That one-half cent per more be, and the same hereby is

levied for a forest fire patrol fund, and the assessor hereby ordered to extend said levy upon the assessment rolls.
