## RESOLUTION

WHEREAS, a County Road in \_\_\_\_\_\_ County, State of Oregon, now known as the \_\_\_\_\_\_ Unatille Oil Depot \_\_\_\_\_\_ County Road, is routed through the County of \_\_\_\_\_\_\_ Oregon, a municipal corporation, and a section of said road has been officially adopted for improvement by the State Highway Commission and \_\_\_\_\_\_\_ County, the section adopted for improvement being more particularly described as follows; to wit: Beginning at a point in the Columbia River Highway approximately 0.75 mile easterly from the cast city limits of Unatilla; thence extending mortherly approximately 1.23 miles to the Unatilla Oil Depot Tank area.

And, WHEREAS, the State Highway Commission of the State of Oregon is desirous of receiving Federal Aid for the improvement of said county road,

And, WHEREAS, the Public Roads Administration of the Federal Works Agency of the United States will not participate in the construction of said county road until and unless the said County of \_\_\_\_\_\_\_ will guarantee by resolution officially adopted by the County Court, that no encroachments will be permitted upon the right of way of said county road within the limits of the section described above, which will permanently obstruct or interfere with the free and convenient flow of traffic over said county road; and will so regulate parking of vehicles on said county road that the free, convenient end safe flow of traffic shall not be impeded; and agree not to impose unreasonable limitations of speed upon said county road, nor impose any regulations of traffic which will operate to discriminate against traffic upon said county road by giving undue preference to traffic upon other intersecting county roads, streets or avenues.

NOW THEREFORE, IT IS HEREBY RESOLVED by the County Court of Unatilla now County, Oregon, that no encroachments will be permitted on the county road,/known unatille Oil Depot as the \_\_\_\_\_\_ County Road, which will permanently or unduly interfere with the free and convenient flow of traffic along said county road; and will so regulate the parking of vehicles along said county road as not to impede the free, convenient and safe flow of traffic; and will not impose any unreasonable limitations of speed upon said county road, nor impose any regulation of traffic upon said county road which shall unduly discriminate against traffic upon said county road by giving undue preference to traffic upon other intersecting county roads, streets or avenues.

It being understood that nothing in this resolution of agreement by the County Court shall be construed so as to prevent or impair proper police regulations and the enforcement of all existing laws and regulations respecting the use of said county road, nor to prevent such temporary obstructions to traffic as may be necessitated by the construction of water or gas mains, sewers and other public improvements, or to preclude the proper use of said county road for the placement of telephone or electric light poles or other public service facilities.
