WARRANTY DEED

KNOW ALL MEN BY THESE PRESENTS, That CLARA A. HALL, Grantor, for the consideration of the sum of Seventeen Thousand Five Hundred Twenty-Five and No/100 DOLLARS (\$17,525.00) received, does hereby convey unto the STATE OF OREGON, by and through its DEPARTMENT OF TRANSPORTATION Highway Division, Grantee, the following described property, to wit:

PARCEL 1

A parcel of land lying in the SEISWI of Section 32, Township 5 North, Range 28 East, W.M., Umatilla County, Oregon; the said parcel being that portion of said SEISW included in a strip of land variable in width, lying on the Southeasterly side of the center line of the Southbound lane of the McNary Highway, which center line is described as follows:

Beginning at Engineer's center line Station "SB" 240+36.83, said station being 1342.61 feet North and 681.51 feet West of the Northeast corner of Section 29, Township 5 North, Range 28 East, W.M.: thence on an 11,459.16 foot radius curve right (the long chord of which bears South 13° 11' 30" West 10,797.74 feet) 11,243.34 feet to Engineer's center line Station "SB" 352+80.17 Back equals "SB" 353+03.83 Ahead; thence South 41° 18' West 2196.17 feet to Engineer's center line Station "SB" 375+00.

A parcel of land lying in the SE¹SW¹ of Section 32, Township 5 North, Range 28 East, W.M., Umatilla County, Oregon; the said parcel being that portion of said SE¹/₂SW¹ lying Southerly of Parcel 1 and included in a strip of land variable in width, lying on each side of the center line of relocated Power Line Road, which center line is described as follows:

Beginning at Engineer's center line Station "PE" 25+00, said station being 466.02 feet North and 1200.40 feet West of the Northeast corner of said SE¹SW¹; thence South 7° 38' East 1919.44 feet; thence on a spiral curve right (the long chord of which bears South 6° 58' East 199.98 feet) 200 feet; thence on a 2864.79 foot radius curve right (the long chord of which bears South 4° 30' 55" East 111.80 feet) 111.81 feet; thence on a spiral curve right (the long chord of which bears South 2° 03' 50" East 199.98 feet) 200 feet to Engineer's center line Station "PE" 49+31.25.

A parcel of land lying in the SE⁺SW⁺ of Section 32, Township 5 North, Range 28 East, W.M., Umatilla County, Oregon; the said parcel being that portion of said SE⁺SW⁺ lying Southerly of Parcel 1 and Westerly of Parcel 2.

The parcel of land to which this description applies contains 0.73 acre, more or less, outside of the existing right of way.

TOGETHER WITH all water rights appurtenant to the above described property, which water rights are for 1.63 acres of land.

RESERVING, However, unto Grantor, her heirs and assigns, a continuous right to use the existing irrigation ditch located on the above described property.

Also for the above stated consideration, there is hereby conveyed to Grantee all existing, future or potential common law or statutory abutter's easements of access to the McNary Highway, and the relocated Power Line Road northerly of Engineer's Station "PE"43+12 on the Easterly side of said road and northerly of Engineer's Station "PE"42+92 on the westerly side of said road, and all of Grantor's remaining property.

And Grantor does hereby covenant to and with Grantee, its successors and assigns, that she is the owner in fee simple of said property which is free from all encumbrances and will warrant and defend the same from all lawful claims whatsoever.
