Commencing at a brass-capped monument marking the Center of Section 7, T. 2 North, Range 32 E.W.M.; thence S00°33'40"W, 229.81 feet along the North-South Centerline of Section 7 to the true point of beginning of this description; thence N55°54'01"E, 89.20 feet; thence N52°22'12"E, 196.38 feet; thence N64°04'15"E, 130.67 feet to the East-West Centerline of said Section 7; thence S89°32'33"E, 18.92 feet along said East-West Centerline; thence S66°19'08"W, 91.73 feet; thence 190.95 feet along a 501.32-foot radius curve left (the chord bears S55°24'25"W, 189.80 feet); thence 167.29 feet along an 1100.00-foot radius curve right (the chord bears S48°51'09"W, 167.13 feet) to the North-South Centerline of Section 7; thence N00°33'40"E, 27.67 feet along said North-South Centerline to the point of beginning.
