NOTICE OF HEARING

WHEREAS the Umatilla County Board of Commissioners on July 17, 1974, filed its Resolution of Intent to Vacate a portion of Old State Highway No. 30 because this portion is useless to the general road system of the County, the area is served by other roads and the public will be benefited by not having to maintain the same, and

WHEREAS this portion of road runs in a East-West direction and is approximately one-fourth (1/4) of a mile long and lies completely within the boundaries of the O. J. and Marjorie Brogoitti property with the following description:

A portion of land lying in the SE¹/₄ of the NE¹/₄ of Section 7, Township 2 North, Range 32, East W.M. All of that portion of land lies South of the southerly rightof-way line of Engineer's centerline described as follows:

Beginning at Engineer's Station Rieth 1209+05.60 P.S., said point being 2590.80 feet South and 2170.72 feet West of Oregon State Highway Department Station "A" 1245+91.29, and on the existing centerline of Old Highway U.S. 30; thence along a spiral curve left, "a" value of 1.0,500.00 feet; thence along a 5° curve left 244.40 feet to Engineer's Station 1216+50.00 P.O.C. Reith equals 1216+50.00 P. O.T.; thence S 55°42' 30" E. 169.12 feet; thence on a 20° curve left 233.67 feet to Engineer's Station Prowler 1212+46.91, said station being on the centerline of Old Highway U.S. 30 and 2265.29 feet South and 1241.68 feet West of Oregon State Highway Department Station "A" 1245+91.29. Also see attached Exhibit "A".

WHEREAS the Umatilla County Board of Commissioners has directed the County Roadmaster for a report asking his opinion on the necessity for such vacation and whether it is in fact useless to the general road system of the County, therefore

BE IT RESOLVED that true copies of the Notice of Hearing, properly certified to be such by the Umatilla County Clerk, shall be posted by the County Roadmaster or his assistants in three (3) places in the vicinity of the said portion of road to be vacated; that one (1) copy be posted upon the bulletin board in the West corridor of the Umatilla County Courthouse in Pendleton,

Oregon, said Umatilla County Courthouse being the place where the Umatilla County Board of Commissioners' meetings are held; that copies shall be mailed to the record owers of the land on which the county road is to be vacated; and that this Notice of Hearing be duly entered in the Commissioner's Journal, therefore the Umatilla County Board of Commissioners

ORDERS a hearing on the Roadmaster's report to be held in Room 114 of the Umatilla County Courthouse in Pendleton, Oregon, on the 18 day of September, 1974, at 10:00 o'clock, at which time the Umatilla County Board of Commissioners will consider the Roadmaster's report and any objections thereto and, unless good cause is shown why the same should not be done, shall thereafter Order that this portion of Old State Highway No. 30 described above be vacated.
