## ORDER

WHEREAS the Umatilla County Board of Commissioners received a request from O. Jay and

Marjorie Brogoitti to Vacate a portion of Old Oregon State Highway No. 30, having the following

description:

A portion of land lying in the SE<sup>1</sup>/<sub>4</sub> of the NE<sup>1</sup>/<sub>4</sub> of Section 7, Township 2 North, Range 32, East W.M. All of that portion of land lies South of the southerly rightof-way line of Engineer's centerline described as follows:

Beginning at Engineer's Station Rieth 1209+05.60 P.S., said point being 2590.80 feet South and 2170.72 feet West of Oregon State Highway Department Station "A" 1245+91.29, and on the existing centerline of Old Highway U.S. 30; thence along a spiral curve left, "a" value of 1.0,500.00 feet; thence along a 5<sup>°</sup> curve left 244.40 feet to Engineer's Station 1216+50.00 P.O.C. Reith equals 1216+50.00 P. O.T.; thence S 55<sup>°</sup> 42' 30" E. 169.12 feet; thence on a 20<sup>°</sup> curve left 233.67 feet to Engineer's Station Prowler 1212+46.91, said station being on the centerline of Old Highway U.S. 30 and 2265.29 feet South and 1241.68 feet West of Oregon State Highway Department Station "A" 1245+91.29. Also see attached Exhibit "A".

WHEREAS the portion of Old Oregon State Highway No. 30 in question runs in a East-

West direction and lies completely within property owned by O. Jay and Marjorie Brogoitti, and

WHEREAS the portion of Old Oregon State Highway No. 30 in question is completely

isolated and cut off by the relocation of Old Oregon State Highway No. 30 and the construction

of the West Pendleton Interchange, and

WHEREAS the Umatilla County Board of Commissioners signed their Resolution of Intent on

July 17, 1974, and

WHEREAS the Umatilla County Roadmaster testified that the portion of Old Oregon State

Highway No. 30 in question is now useless to the general road system, and

WHEREAS a Hearing in the Matter of Vacating that portion of Old Oregon State Highway

No. 30 was held in the Umatilla County Courthouse on September 18, 1974, as required by

Oregon State Law, and

WHEREAS there were no remonstrances against the Vacation of that portion of Old Oregon State Highway No. 30.

THEREFORE the Umatilla County Board of Commissioners, finding it in the best interest of the citizens of Umatilla County, ORDER that portion of Old Oregon State Highway No. 30, as requested, VACATED.
