ORDINANCE NO. 3289

AN ORDINANCE VACATING A PORTION OF COUNTY ROAD #506 FROM ITS INTERSECTION WITH S.W. HAILEY AVENUE TO ITS INTERSECTION WITH S.W. GOODWIN PLACE.

I. RECITALS.

A. WHEREAS, pursuant to ORS 271.080, Carlos Van Elsberg, Public Works Director for Umatilla County, on December 6, 1983, filed a request with the City of Pendleton to vacate a portion of County Road #506, for the reason that it serves no useful purpose. A copy of Mr. Van Elsberg's request is attached hereto as Exhibit "A" and by this reference incorporated herein.

B. WHEREAS, pursuant to ORS 271.080, and as a basis for granting the request to vacate, the consent of the owners of all abutting property and of not less than two-thirds in area of the real property affected thereby have consented to such vacation as evidenced by Exhibit "B" attached hereto and by this reference incorporated herein.

C. WHEREAS, the City Recorder has caused such petition referred to above to be filed pursuant to ORS 271.090 and has advised Mr. Van Elsberg of the date the petition will come before the City Council.

D. WHEREAS, pursuant to ORS 271.100, the City Council after ascertaining that there appeared to be no reason why the petition should not be allowed set a time for formal hearing upon the petition, pursuant to Resolution No. 1319 attached hereto as Exhibit "C" and by this reference incorporated herein, which Resolution passed on the 17th day of January, 1984, initiating vacation proceedings for property hereinafter described and fixed the hour of 7:35 p.m. on the 21st day of February, 1984, as the time, in the Council Chambers as the place, for the hearing of any and all objections or remonstrances relating to the vacation of said property.

E. WHEREAS, the City Recorder has caused pursuant to ORS 271.110 the notice of the petition and hearing to be published in the City official newspaper once each week for four (4) consecutive weeks with said notices containing a description of the ground covered by the petition, the date it was filed, the name of at least one of the petitioners, and the date when the petition and any objection or remonstrance which may be made in writing and filed with the recording officer of the City prior to the time of the hearing and will be heard and considered.

F. WHEREAS, the City recording officer five (5) days after the first day of the notice caused to be posted at or near each end of the proposed vacation a copy of the notice headed "Notice of Street Vacation" posted in at least two (2) conspicuous places in the proposed vacation area with said posting not less than twenty-eight (28) days before the hearing.

G. WHEREAS, c the 3rd day of November, 1983, e Pendleton Planning Commission considered the above request as a land use issue and adopted the recommendation of Mike Hyde, Senior Planner, as their recommendation to the County Board of Commissioners that the subject right of way be vacated which action is reflected in the Planning Staff Report (findings of fact and conclusions of law) of November 3, 1983 attached hereto as Exhibit "D" and by this reference incorporated herein as if set forth fully. Said recommendation is also directed to the City Council, which has jurisdiction as the County road to be vacated lies within the Pendleton city limits.

NOW THEREFORE CITY OF PENDLETON ORDAINS AS FOLLOWS:

SECTION 1. The City Council of the City of Pendleton finds as follows:

- A. A consent of the owners of the requisite area has been obtained.
- B. The City Council finds that notice has been duly given.
- C. The City Council finds that the public interest will not be prejudiced by the vacation of such part of the street.

SECTION 2. The City Council of the City of Pendleton hereby and forever vacates the following described real property:

A portion of County Road #506 lying north of S.W. Hailey Avenue, east of S.W. Goodwin Place, described as follows:

Commencing at the Southeast corner of the S.W. 1/4 of the S.E. 1/4, Section 9 T2N R32 E.W.M.

Thence North 29° 13' 45" West a distance of 34.48 feet to a point on the Northerly right-of-way of S.W. Hailey Avenue, said point being the true point of beginning:

Thence continuing North 29° 13' 45" West a distance of 188.28 feet: Thence along a circular curve to the left a distance of 24.42 feet more or less to a point on the Easterly right-of-way line of S.W. Goodwin Avenue and the terminus point for this description. Said curve having a radius of 524.05 feet and a L.C. of (North 30° 33' 55" West a distance of 24.42 feet):

Said road being 30.00 feet in width, lying 15.00 feet either side of the above described centerline.

All information shown is based on the City of Pendleton's Survey Drawing No. 24-7769.

All as described in Exhibit "E" and by this reference incorporated herein.

SECTION 3. The City Council further finds that the title to the street shall attach to the lands bordering on such area in equal proportion pursuant to ORS 271.140.

SECTION 4. The City Council further finds and orders pursuant to ORS 271.150 that a certified copy of this Ordinance vacating the street together with the map attached herein shall be filed for recording with the County Clerk. The petitioner for vacation shall bear the recording costs and the cost of preparing and filing the certified copy of the Ordinance and map. He shall also file a certified copy of such Ordinance with the County Assessor and the County Surveyor.

If a public square is vacated the title thereto shall vest as provided by ORS 271.060.

I also understand that under Oregon law if I did not consent to the above vacation and if the vacation substantially affected the market value of my property, the City Council could not vacate the above street without provision for paying me damages as provided in ORS 271.130
