I, Wayne O. Harris, Professional Land Surveyor number 346, registered in the State of Oregon hereby certify that I have correctly surveyed and marked with proper monuments this replat of lots 12 -15 of Block 1 of Valley View Estates, an Addition to the City of Pendleton in the County of Umatilla belonging to Lenny and Kelli Leen as recorded on Roll 186 page 1603 Umatilla County Deed Records and Todd and Pauline Davis as recorded on Roll 270 Page 121 said Deed Records. These Parcels had been previously platted on the 4th of April, 1978. Pins were found as shown. There were some discrepancies but since the were original points they were allowed to stand and distances were adjusted. Bearings are based on the monuments found on the West line of Valley View Estates. The new county road alignment was set by the Umatilla County road crew.
