EASEMENT DEED

KNOW ALL MEN BY THESE PRESENTS:

THAT, OREGON-WASHINGTON RAILROAD & NAVIGATION COM-PANY, a corporation of the State of Oregon, and its lessee, UNION PACIFIC RAILROAD COMPANY, a corporation of the State of Utah, collectively the Grantor, in consideration of the sum of One Dollar (\$1.00) and other good and valuable consideration to it paid, the receipt of which is hereby acknowledged, does hereby grant, bargain, sell and convey unto COUNTY OF UMATILLA, STATE OF OREGON, Grantee, a PERPETUAL EASEMENT solely for roadway purposes upon, over and along the property of the Grantor situate in the County of Umatilla, State of Oregon, described in Exhibit A, hereto attached.

RESERVING, however, to the Grantor, its successors and assigns, the right to construct at any and all times and to maintain railroad tracks, pipe lines and telephone, telegraph and electric power pole and wire lines, over, under and across such roadway of the Grantee on the premises described in Exhibit A; it being understood that the right so reserved to the Grantor, its successors and assigns, is retained along with the general right of the Grantor, its successors and assigns, to the use of such premises for any purpose not inconsistent with the use by the Grantee of such easement for the purposes herein defined.

The Grantee agrees to assume, bear and pay all taxes and assessments of whatsoever kind or nature (whether general, local or special) levied or assessed upon or against the premises described in Exhibit A, excepting taxes levied upon and against such property as a component part of the Grantor's operating property as a whole.

This deed is made subject to all outstanding leases and other outstanding rights, including, but not limited to, those for highways and other roadways and rights of way for irrigation ditches, pipe lines, pole and wire lines and the right of renewals and extensions of the same, and subject also to all conditions, limitations, restrictions, encumbrances, reservations or interests of any person which may affect the said land, whether recorded or unrecorded, and is made without covenant of title or to give possession or for guiet enjoyment. It is expressly made a condition of this easement that if the Grantee, its successors or assigns, shall abandon the premises of the Grantor in the location described in Exhibit A, or any portion of such premises, for the purposes of this easement, then and in that event all the rights herein granted shall cease and determine with respect to the premises so abandoned, and the title to such premises shall be freed from the burden of such easement; and it is further agreed that nonuser of the premises described in Exhibit A or any portion thereof for the purposes of such easement for the premises or portion thereof not used.

A strip of land 50.0 feet in width situate in the South Half of the Northeast Quarter (Sl/2NE1/4) and the Southeast Quarter of the Northwest Quarter (SE1/4NW1/4) of Section 31, Township 4 North, Range 29 East of the Willamette Meridian, Umatilla County, State of Oregon, such strip of land lying 25.0 feet on each side of the following described centerline and such centerline prolonged:

Commencing at the East Quarter (E1/4) Corner of such section, from which the Northeast (NE) Corner of the section bears North 0° 33' 00" West, a distance of 2608.96 feet;

thence North 89° 21' 55" West, a distance of 712.99 feet;

thence North 42° 06' 34" West, a distance of 33.54 feet to the true point of beginning;

thence South 89° 42' 10" West, a distance of 1930.08 feet;
