KNOW ALL MEN BY THESE PRESENTS, That Hansell Brothers, Inc., an Oregon corporation, Grantor, for the consideration of the sum of Three Hundred Eighty and No/100 Dollars (\$380.00) and other valuable consideration by it received, has bargained, and sold and by these presents does bargain, sell and convey unto the State of Oregon, by and through its State Highway Commission, the following described premises, to wit:

A parcel of land lying in the  $SW_4^1NE_4^1$  and the  $N_2^1SE_4^1$  of Section 27, Township 4 North, Range 27 East, W.M., Umatilla County, Oregon; the said parcel being that portion of said  $SW_4^1NE_4^1$  and the  $N_2^1SE_4^1$  included in a strip of land variable in width, lying on the Southerly side of the center line of the Eastbound lane of the relocated Old Oregon Trail Highway as said highway has been relocated, which Eastbound lane center line is described as follows:

Beginning at Engineer's center line Station "EB" 760+00, said Station being 9197.57 feet North and 688.60 feet West of the Southwest corner of Section 34, Township 4 North, Range 27 East, W.M.; thence South 77° 06' 54" East, 7000 feet to Engineer's Station "EB" 830+00, said center line crosses the East line of said Section 27, approximately at Engineer's Station "EB" 820+20.
