in the State of Oregon, in consideration of the benefits and other valuable considerations, and the sum of One Dollar

paid to them the receipt whereof is hereby acknowledged

have granted, bargained, sold and conveyed, and by these presents do grant, bargain, sell and convey unto the County of Umatilla, State of Oregon, the following described parcel of land, situate in Umatilla County, in the State of Oregon, to-wit: A strip of land thirty feet wide, being thirty feet wide on the north side of the center line of County Road No. 616 as laid out across the south end of the South half of the Southwest Quarter of the Northwest Quarter of Section 33, Township 4 North, Range 28 East, W.M. Said strip of land being more particularly described as follows; Beginning at the Quarter Section corner common to Sections 32 and 33, thence North along the Section line, 30 feet, thence East following a line 30 feet north of and parallel to the Quarter Section line, approximately 1320 feet to the 1/16 Section line, thence South 30 feet to Southeast corner of the Southwest Quarter of the Northwest Quarter of Section 33, thence West along the Quarter Section line approximately 1320 feet to the place of beginning. All in Township 4 North, Range 28 East, W.M.



To have and to hold the same, unto the County of Umatilla, State of Oregon, for the purpose of a public road forever.

The Grantee herein agrees, that in the construction and maintenance of said road, it will not cut or destroy the row of shade trees now growing on the east portion of the above described strip of land.
