

Notice is hereby given that a petition will be presented to the Howard County Court of the State of Oregon for Umatilla County at the next regular term of said Court to-wit at the September term 1883; praying for the view survey location and establishment of a County road commencing at a stake driven on the County road running from ranch of O. T. Thompson on Butter Creek to Echo between the 8th and 9th quarter ($\frac{1}{4}$) mile East of said 5th mile Post mile posts on said road; thence running northeasterly to the south end of the Lane known as the Peil Lane at the quarter section post between Sections 7 and 18 in Twp 3 N R 29 East, thence north along said Lane to the quarter section post between Sections 6 and 7 in said Twp & Range, thence north on same line in middle of Section 6 to the 1st line hence east along ^{near} the west line of said Section 6 Twp 3 N R 29 East about $\frac{1}{4}$ mile on high ground, thence in a northeasterly direction to the Umatilla River at a point opposite the foot of Seymour street in the town of Foster in said County, thence across said Umatilla River and along said Seymour street, to the east boundary line of said town of Foster, thence along Prospect street to the north boundary line of said town of Foster, thence north about 500 feet, thence in an easterly direction to the center of Section 33 Twp 4 N R 29 East.
