Know All Men by These Presents, That we, Samuel L. Carson and Gladys

A parcel of land lying in Lot 1, Block 1, MEADOW VALLEY, located in Section 36, Township 4 North, Range 27 East, W.M., Umatilla County, Oregon, and being a portion of that property described in that contract to Dwight C. Hulit and Edith Hulit, recorded in Book 279, Page 180, of Umatilla County Records of Deeds; the said parcel being that portion of said property lying Northeasterly of a line which is parallel to and 40 feet Southwesterly of the center line of a frontage road, which center line is described as follows:

Beginning at Engineer's center line Station "FR" 914+00.32, said Station being 77.52 feet North and 1484.27 feet West of the Northeast corner of said Section 36; thence on a spiral curve right (the long chord of which bears South 75° 54' 54" East) 240 feet; thence on a 1909.86 foot radius curve right (the long chord of which bears South 65° 28' 39" East) 535.83 feet; thence on a spiral curve right (the long chord of which bears South 55° 02' 24" East) 240 feet; thence South 53° 50' 24" East, 454.13 feet to Engineer's center line Station 928+70.28. Said center line crosses the West and East lines of said property approximately at Engineer's Stations "FR" 920+60 and "FR" 923+35, respectively.

EXCEPT therefrom a tract of land lying between lines which are parallel to and 30 feet Northerly and 70 feet Northerly of said center line and between lines drawn at right angles to said center line at Engineer's Stations "FR" 920+75 and "FR" 921+76.15, respectively.

(Bearings used herein are based upon the Oregon Co-ordinate System, North Zone.)

The parcel of land to which this description applies contains 1.07 acres outside of the existing right of way.

As a part of the consideration hereinabove stated, there is also bargained, sold, conveyed and relinquished to the Grantee all existing, future or potential common law or statutory abutter's easements of access between the right of way of the public way identified as the relocated Old Oregon Trail Highway and all of the Grantors' real property described in said Book 279, Page 180, remaining after the conveyance herein made, EXCEPT, however,

Grantee shall either construct a public frontage road or provide some other access road on the Southwesterly side of the highway, and the Grantors, their heirs and assigns, shall be entitled to reasonable access to the said road for any purpose, upon application filed with the State pursuant to applicable statutes and regulations. Said road shall be connected to the main highway or to other public ways only at such places as the Grantee may select.

It is expressly intended that the covenants, burdens, restrictions and reservations contained herein shall run with the land and shall forever bind the Grantors, their heirs and assigns.
