

P E T I T I O N

TO THE UMATILLA COUNTY BOARD OF COMMISSIONERS, STATE OF OREGON

WE, THE UNDERSIGNED REGISTERED VOTERS IN THE COUNTY OF UMATILLA, STATE OF OREGON, RESPECTFULLY REQUEST THE BOARD OF COMMISSIONERS TO VACATE AND RELINQUISH ANY RIGHT, TITLE OR INTEREST IN COUNTY ROADS AS FOLLOWS, TO-WIT:

Any and all county road or roads situated, or recorded or shown in any county records as being located, within the following area;

Beginning at a point where Butter Creek intersects the boundary between Umatilla County and Morrow County, State of Oregon; running thence Northeasterly along the West bank of said Butter Creek to a point where Butter Creek intersects with the Westland "High Line" Canal (in the Northwest Quarter of Section 8, Township 3 North Range 28, E.W.M., Umatilla County, Oregon); running thence Westerly along the South bank of said Westland "High Line" Canal to the boundary between Umatilla County and Morrow County, State of Oregon; and running thence South along said boundary line to the point of beginning.

Said area is delineated in red color border on the map, attached hereto, but any discrepancy between said map and said description shall be resolved in favor of said description.

THE PUBLIC NECESSITY FOR SUCH BEING AS FOLLOWS: (1) All or substantially all of such roads are unused by the general public, primitive, and are presently not used as roads at all, same being mostly under cultivation, many being intersected by fences, and all have been used for cultivation for 20 years or more; and (2) Use of such roads by members of the general public would present a dangerous condition, for the roads are essentially impassible, and use would also present a fire threat; and (3) The general public would be benefitted by using public funds for maintenance of roads within the general road system; and (4) the roads within such area are useless as a part of the general road system, dangerous and burdensome to maintain, and the general public would be benefitted by the vacation of same.

Each of the undersigned are owners, or persons having a beneficial interest in land in the above described area.

TO THE UMATILLA COUNTY BOARD OF COMMISSIONERS, STATE OF OREGON

WE, THE UNDERSIGNED REGISTERED VOTERS IN THE COUNTY OF UMATILLA, STATE OF OREGON, RESPECTFULLY REQUEST THE BOARD OF COMMISSIONERS TO VACATE AND RELINQUISH ANY RIGHT, TITLE OR INTEREST IN COUNTY ROADS AS FOLLOWS, TO-WIT:

Any and all county road or roads situated, or recorded or shown in any county records as being located, within the following area;

Beginning at a point where Butter Creek intersects the boundary between Umatilla County and Morrow County, State of Oregon; running thence Northeasterly along the West bank of said Butter Creek to a point where Butter Creek intersects with the Westland "High Line" Canal (in the Northwest Quarter of Section 8, Township 3 North Range 28, E.W.M., Umatilla County, Oregon); running thence Westerly along the South bank of said Westland "High Line" Canal to the boundary between Umatilla County and Morrow County, State of Oregon; and running thence South along said boundary line to the point of beginning.

Said area is delineated in red color border on the map, attached hereto, but any discrepancy between said map and said description shall be resolved in favor of said description.

THE PUBLIC NECESSITY FOR SUCH BEING AS FOLLOWS: (1) All or substantially all of such roads are unused by the general public, primitive, and are presently not used as roads at all, same being mostly under cultivation, many being intersected by fences, and all have been used for cultivation for 20 years or more; and (2) Use of such roads by members of the general public would present a dangerous condition, for the roads are essentially impassible, and use would also present a fire threat; and (3) The general public would be benefitted by using public funds for maintenance of roads within the general road system; and (4) the roads within such area are useless as a part of the general road system, dangerous and burdensome to maintain, and the general public would be benefitted by the vacation of same.
