It appeared that due proof of the posting of said order or notices is on file herein at that such affidavit is now before the Court and

It appearing that no objections have been made or filed to such proposed vacating, and

It appearing that said road so proposed to be vacated is not useful as a part of the general system of Umatilla County, Oregon, and it appearing that the public will be benefitted by such vacating and the such road will not in the future be useful as a part of the general road system and is not of sufficient public benefit to warrant the same being maintained by the County.

IT IS THEREFORE CONSIDERED, ORDERED AND ADJUDGED that said road be vacated as follows:
