

IN COUNTY COURT, *September* TERM, 1898
Sixth JUDICIAL DAY, *Saturday, September 10th* 1898

Court met on this date pursuant to adjournment and there were present:-

And after due proclamation of the opening of Court by the proper officer the following business was transacted together with claims allowed as shown by Book No 3, 'Abstract of Claims' Page 57, et seq.

Now on this day it is ordered by the Court that the claim of N E Bradley be, and the same hereby is continued until the next regular term of this Court.

In the matter of County Road No 499, commencing on present County Road at a certain post marked 'R', forty rods north of the SW corner of Sec 21 in T 1 S R 32 E N M; thence South on Sec line 25 and 33, to the Southwest corner of the Northwest quarter of Sec 33, T 1 S R 32 E N M. Thence East on S. line of SW 1/4 of NN quarter of Sec 33, T 1 S R 32 E N M until it strikes or intersects the now or present traveled road; thence south-easterly direction on the present traveled road to a point 218 feet south of the bridge on Birch Creek at a certain Gate Post marked 'R' where the above route intersects the now said out road up East Birch Creek, on the Township line 18 rods East of the SW corner of the SE 1/4 Sec 33, T 1 S R 32, E N M.

Now on this day comes the report of the viewers, D Belts L A Dickerson and R Dick, heretofore appointed at the July, 1898, term of this Court to view out and report upon the location of the above road as a County Road for file hearing, the same having been read on a previous day of this Court to-wit, the July, 1898 term; and the said viewers having reported favorably and recommending the establishing of the same as a County Road, and the field notes and plat of survey being duly on file and certified to by the

surveyor appointed to survey the same, and there being no remon-
strance or claim for damages on file against said road,

It is therefore ordered that the report of said viewers be accepted and
that the said road be established as a County road in accordance with
the report of said viewers, and that the said report, field notes and
plat of survey thereof be recorded as by law required, and that the
supervisor through whose District said road runs be directed to
open the same for public use as a County Road.

In the matter of County Road No 496 Commencing
at a point 80 rods South of the NE Corner, Sec 7,
in Tp 2 N R 32 E N M, thence in a westerly direction fol-
lowing the old traveled road from James Daniels place
to Barnhart Station as near as most practicable for
an easy grade through Sec 7 in Tp 2 N R 32 E
N M and Secs 12 and 13 in Tp 2 N R 31 E N M, to
a point 17 rods north of the SW Corner Sec 12, in
Tp 2 N R 31 E N M.

Now on this day comes the report of the viewers heretofore
appointed to view out and assess the damages in the cases of those
persons having claims in for damages to their lands by reason of
the location of the proposed County road No 496, through the same,
assessing said damages at \$40.00 to Mrs Sarah Thompson, and the mat-
ter coming up for final hearing, the same having been read at a
term, to-wit: the May term, 1895, of said Court, and the viewers
having reported favorably and recommended the establishing of the same
as a County road, and the field notes and plat of survey being duly on
file and certified to by the surveyor appointed to survey the same.

It is therefore considered, ordered and adjudged by the Court that the
said road be established as a County road in accordance with the report
of said viewers, and that the field notes and plat of survey thereof be re-
corded as by law required, and the road ordered opened when
the damages assessed by the viewers be paid by the petitioners.
