Beginning at the Southeast corner of the Southwest quarter of Section 12, Township 1 South, Range 31 East, Willamette Meridian, running thence North on line between the East and West halves of said Section 12, a distance of about 3,917 feet, thence in a Northwesterly direction across the N rthwest quarter of Section 12, and the Northeast quarter of Section 11, to intersect the open roadway at a point about 917 feet west of the Northeast corner of Section 11. The right-of-way of the aforesaid road being 40 feet.
