WHEREAS in accordance with ORS 368.201 to 368.221, the Umatilla County Board of Commissioners may initiate proceedings to legalize a county road that has been used and traveled by the public for ten years or more, and

WHEREAS the Board of Commissioners adopted Order No. RD2014-44 to order a survey of a portion of Stock Drive Road and Delwood Place (a.k.a. Delwood Street), County Road No. 1388, lying between Northwest Cedar Street and the ¼ Corner common to Sections 8 and 17, Township 1 South, Range 32 E.W.M. in and adjacent to the city limits of Pilot Rock, Oregon, and

WHEREAS a public hearing was set for December 3, 2014 to consider the legalization of the road, and notice of the hearing was posted on November 12, 2014 in three public places, published in the East Oregonian on November 12, 2014 and November 26, 2014, and all owners of abutting property affected by the legalization procedure were mailed copies of the notice of the hearing, and

WHEREAS the Board of Commissioners held a public hearing on December 3, 2014, and found that it would be in the public interest to legalize the road.

NOW THEREFORE IT IS ORDERED that the location of Stock Drive Road and Delwood Place (a.k.a. Delwood Street), County Road No. 1388, is legalized as follows:

#### <u>Unit "A"</u>

A strip of land varying in width for road and utility installation purposes located in the Southeast ¼ of Section 8 and the Northeast ¼ of the Northeast ¼ of Section 17, Township 1 South, Range 32 E.W.M., the exterior of which is more particularly described as follows:

Beginning at a ½-inch rebar marking the Northeast Corner of Lot 6, Block 2, Moltke's Addition to the City of Pilot Rock, said rebar marking an angle point in the east boundary of Moltke's Addition and the west right of way line of County Road No. 1388 and bearing S51°55′21″E, 736.41 feet from a 2-1/2 inch brass disk set in concrete marking the Initial Point of Moltke's Addition and the East 1/16<sup>th</sup> Corner common to Sections 8 and 17; thence S15°50′55″W, 110.20 feet to the Northeast Corner of Lot 7, Block 2, Moltke's Addition; thence N40°55′55″E, 31.49 feet to a point on the southwesterly extension of the west right of way line of Northwest Cedar Street (formerly County Road No. 1386, Circle Road); thence N18°52′31″E, 181.77 feet to a 5/8inch rebar marking the intersection of the southwesterly extension of the west right of way line of Northwest Cedar Street with the southeasterly extension of the east right of way line of County Road No. 1388; thence N4°45′46″W, 61.75 feet to the northwest corner of that property conveyed to the City of Pilot Rock by Donald Royer, recorded in Reel 43, Page 1138, Umatilla

Right of way widths, referring to engineering stations from Survey No. 14-139-C, are 30.00 feet on the left side of centerline for the entire road and taper from 26.77 feet at Station 1+35.40 to 26.87 feet at Station 1+97.15 to 27.19 feet at Station 4+57.90 to 30.00 feet at Station 6+37.83 and remain at 30.00 feet for the remainder of the road on the right side of centerline.
