
SECTION 27, T3S, R31E, W.M., UMATILLA COUNTY. OREGON





NARRATIVE OF SURVEY

This survey was performed at the request of Mr. Gordon Byrnes The purpose of the survey was to monument the boundaries of his land as shown hereon and also to determine the extent of the encroachment by the fence line in the SW1/4 of the NE1/4 of the section.

I was a crew member on the survey done in 2000 (00-252-B) and am familiar with the section corner monumentation as shown hereon. I found all of the section corner monumentation as shown in that survey to be in good condition and undisturbed.

The legal descriptions for the lands in this section are aliquot part descriptions. I calculated the corner locations for this survey from ties to the section corner monumentation using the standard procedure in the manual of instructions. Control ties were done with a Trimble R7/R8 RTK GPS System and all monuments were set with that system except the CE1/16th and NE1/16th. Due to interference from the trees, those monuments were set with a Trimble 5601 Robotic Total Station.

It was reported to me that some of the land owners had marked their own corners in this section. I was shown some of those marks and it does not appear that any possessory lines were established from them. The Byrnes property is un-fenced except for the eastern most line. The landowners indicate that the fence has been in its current location for some time but I cannot certify any specific date. There are indicators that the fence has been replaced in some locations.
