
# BOUNDARY LINE ADJUSTMENT

#### SURVEYOR'S NARRATIVE

THIS SURVEY WAS UNDERTAKEN IN OCTOBER OF 2016 AT THE REQUEST OF SLADE AND TAMARA SMITH. THE PURPOSE OF THE SURVEY IS TO PERFORM A BOUNDARY LINE ADJUSTMENT BETWEEN 2 INDIVIDUAL TAX LOTS (TL 401 & TL 600). THE INTENT OF THIS BOUNDARY LINE ADJUSTMENT IS TO ADJUST THE CURRENT BOUNDARY LINES TO CORRELATE AND MATCH WITH THE LOCATIONS OF AN EXISTING FENCE LINE.

BEARINGS AND THE SECTION BREAKDOWN ARE BASED ON A SURVEY COMPLETED BY THIS FIRM IN 2016 FOR OREGON STATE UNIVERSITY SEE SURVEY NUMBER 16-081-B. LEGAL DESCRIPTIONS OF RECORD ON THE FACE OF THIS PLAT HAVE BEEN COPIED WORD FOR WORD AS THEY ARE RECORDED WITH UMATILLA COUNTY RECORDS. THERE ARE TYPOS IN THOSE DEEDS AS WHAT IS SHOWN.

THE LEGAL DESCRIPTIONS OF RECORD FOR THE PROPERTIES IN THE NW 1/4 OF THE NE 1/4 OF THE SW 1/4 OF SECTION 14 ARE ALL ALIQUOT PARTS DESCRIPTIONS. I WAS ABLE TO COMPUTE THE LOCATIONS OF THE LEGAL DESCRIPTIONS IN THE NW 1/4 OF THE NE 1/4 OF THE SW 1/4 OF SECTION 14 BASED ON THE BREAKDOWN OF SAID SECTION 14. ALL OF THE LEGAL DESCRIPTIONS EXCEPT FOR THE ONES DESCRIBING TAX LOT 401 AND TAX LOT 700 CLOSED AND FIT WELL BASED UPON THE SECTION BREAKDOWN. THERE IS AN OVERLAP AND DISCREPANCY BETWEEN TAX LOT 401 AND TAX LOT 700 IN A NORTH—SOUTH DIRECTION BOTH ON THE WEST SIDE AND EAST SIDE OF SAID TAX LOTS. THE PROPERTY OWNER FOR TAX LOT 401 INFORMED ME TO MAKE THE PROPERTY LINE AS PER THE DEED FOR TAX LOT 700, THIS IN TURN WOULD MATCH THE LOCATION OF THE FENCE LINE MUCH BETTER.

THE BASIS OF BEARING FOR THIS BOUNDARY LINE ADJUSTMENT ARE FROM THE FOUND 2-1/2" BRASS CAP MARKING THE SOUTH-WEST CORNER OF SECTION 14, AND THE 2-3/8" BRASS CAP MARKING THE SOUTH 1/4 CORNER OF SECTION 14 BOTH LOCATED IS TOWNSHIP 4 NORTH, RANGE 28, EAST OF THE WILLAMETTE MERIDIAN, AND IS BASED ON THE PREVIOUSLY MENTIONED SURVEY THIS FIRM PERFORMED FOR OREGON STATE UNIVERSITY IN 2016.

THIS SURVEY WAS ACCOMPLISHED UTILIZING 2 TRIMBLE R-10 GNSS RECEIVERS. AN AUTONOMOUS POSITION WAS GENERATED ON THE BASE UNIT AND A SITE CALIBRATION WAS ACCOMPLISHED ON THE 2 MONUMENTS PREVIOUSLY MENTIONED THAT WERE HELD AS THE BASIS OF BEARING.

#### LEGAL DESCRIPTION OF RECORD FOR INST. NO. 2016-6440312 (TL 600)

Tract of land in Northeast Quarter of Southwest Quarter of Section 14, Township 4 North, Range 28, East of the Willamette Meridian, Umatilla County, Oregon, and being a portion of that tract of land conveyed to W.J. Railroad Ties and Supply Inc., by deed recorded on Reel 49, Page 378, Deed Records, and being described as follows:

Beginning at Northwest corner of said Northeast Quarter of Southwest Quarter; thence East along North line of said Northeast Quarter of Southwest Quarter a distance of 421 feet to Northeast corner of said Railroad Tracts; thence South along East line of said Railroad Tract a distance of 256.25 feet to the true point of beginning for this description; thence Continuing South along East line of said Railroad Tract a distance 395.75 feet; thence West parallel to and 652 feet distant from North line of said railroad tract a distance of 249 feet; thence North, parallel to and 249 feet distant from East line of said Railroad Tract a distance of 317.30 feet; thence East, parallel to and 256.25 feet distant from North line of said Railroad Tract a distance of 213 feet to a point on East line of said Railroad Tract and the point of beginning.

TOGETHER WITH AND SUBJECT TO an easement for ingress, egress, and utilities over and across North 50 feet of West 446 feet of Southwest Quarter, and over and across East 50 feet of West 446 feet of North 827 feet of said Northeast Quarter of Southwest Quarter.




