I have corrected the west bearing of Tract I of the survey based on the previous surveys and have shown the transfer of property between the two lots as desired by the owner. I found King's dimemsions to be very accurate excepting for the monuments not found. I replaced those missing corners according to the new descriptions and lot configurations along with setting the new corner, as shown, accordingly.
