THE SOUTHWEST SECTION CORNER WAS COMPUTED AT A DIST.-DIST. INTERSECTION BY HOLDING THE DISTANCES AS SHOWN ON SURVEY NO. L-42-A.

THE WEST 1/4 CORNER, THE SOUTH 1/4 CORNER AND THE CENTER 1/4 CORNER WERE THEN COMPUTED AS PER 2009 MANUAL OF SURVEY INSTRUCTIONS.




