## NARRATIVE DISCUSSION:

FOUND MONUMENTS USED FOR CONTROL ON THE BOUNDARY OF THE WEST HALF OF SECTION 15 ARE IDENTIFIED ON SHEET 1 OF 2. I NOTE C.E. REDFIELD, U.S. INDIAN SERVICE SURVEYOR, RAN NORTH-SOUTH ALONG THE NORTH-SOUTH CENTER LINE OF SECTION 15 WHEN SETTING ALLOTMENT CORNER MONUMENTS IN THIS SECTION, RATHER THAN THE NORMAL EAST-WEST "THREE MILE RULE" METHOD. I NOTE THE 1988 BLM SURVEY REESTABLISHED THE NORTHWEST CORNER OF SECTION 15 AT THE VISUAL ROAD INTERSECTION RATHER THAN USING THE WITNESS CORNER FOUND 25.00 FEET EAST OF THE CORNER POINT ON SURVEY NO. 82-84-AX.

THIS SURVEY WAS MADE WITH TRIMBLE 5700 GEODETIC GPS RECEIVERS OPERATED IN STATIC AND REAL TIME KINEMATIC MODES.
