PREVIOUS RENEWALS/SURVEYS ETC.: Corner originally established by David Thompson, under GLO Contract 106, dated August 1864, notes state: Set post for corner to Secs. 3, 4, 33, 34 in mound of Earth with charred stake, pits, trench, &c as per instructions. In Umatilla County Survey No. 88-18-B, William Wells held the intersection of the South Cold Springs Road and a fence line extending South as evidence of the corner position.

MONUMENT SET: The fence extending South is now removed. At the reestablished corner point, set a 5/8" x 24" rebar with 2" aluminum cap, 1" below asphalt, stamped as stated in "Monument Marking Detail", from which:

A 5/8" x 24" iron rod with a 1 1/4" purple plastic cap stamped "Wells Surveying, PLS 54756" bears North 47  $\frac{1}{2}$  ° East, 42.0 feet.

A 5/8" x 24" iron rod with a 1 1/4" purple plastic cap stamped "Wells Surveying, PLS 54756" bears South 54° East, 36.7 feet.

A 5/8" x 24" iron rod with a 1 1/4" purple plastic cap stamped "Wells Surveying, PLS 54756" bears South  $10^{\circ}$  West, 22.0 feet.

A 5/8" x 24" iron rod with a 1 1/4" purple plastic cap stamped "Wells Surveying, PLS 54756" bears North  $46^{\circ}$  West, 34.9 feet.
