Found  $2\frac{1}{2}$  iron pipe with  $3\frac{1}{4}$  brass cap (as shown in corner diagram)

in mound of stone.

A 12" dead douglas fir brs N6810E, 34.1'with scribing visible. Ponderosa pine sawn stump about 4' high and 32" diam brs N49½°E, 64.2' with scribing visible.

A 23" ponderosa pine brs S63.3/4°E, 26.8'with scribing visible. A 20" douglas fir brs S60½ W, 22.5' with pitched over blaze. A 12" douglas fir brs N11°W, 33.7' with pitched over blaze.

## Description of monument and accessories I established to perpetuate the original location of this corner:

Set steel fence post next to corner with sign 54-9 attached.

New bearing tree established: A 7" ponderosa pine bears N31½°E, 52.3' scribed T4SR32ES23 BT.

New BT has a brass washer stamped PLS 1106 nailed to face of blaze. Attached sign 54-3 & 54-9, painted face of blaze & a 6" red band around each BT.

Compass declination 180 East.
