

Previous Renewals / Surveys, etc.

Corner was originally set by Odell and Lewis under contract No. 110 dated February 7, 1865. Their record reads: Set 1/4 Sec. post. Drove charred stake, dug pits and raised mound as per instructions. In the record of private surveys Book, Page 393, John Kimbrell reports: Found mound and pits almost obliterated. The old cottonwood post fairly well preserved in a small mound of stone.

Monument and Accessories found: (condition and source)
None. This point falls in a plowed field.



MONUMENT (S) AND ACCESSORIES SET (Procedures and Description)

I set a 1 1/2"  $\hat{x}$  30" galvanized iron pipe with  $\hat{a}$  2 3/8" brass cap stamped as shown in the diagram above 2 feet below the surface of the plowed field at the position determined from Kimbrell's record.

For references, I set four 5/8" by 24" iron rebars with 1 1/8" orange plastic caps stamped WTS and 56295LS as described below:

an iron rebar bears N65°41'34"W, 48.93 feet, west of the west edge of the field; an iron rebar bears N27°30'04"E, 27.38 feet, 20 inches below the surface; an iron rebar bears S69°04'55"E, 26.86 feet, 20 inches below the surface; an iron rebar bears S26°24'36"W, 49.01 feet, west of the west edge of the field;

The monument was set and references tied using a Trimble R7/R8 RTK GPS.
