A tamarack 10 ins. in dia bears S57 W,24 lks dist marked T5SR34ES19 BT.
A tamarack 7 ins. in dia bears S35 E,9 lks dist marked T5SR34ES20 BT.

Description of corner evidence found:

A 16" western larch stump bears N12°E, 20 1ks (13.21) with blaze and axe marks visible...scribing burnt out. A stump hole bears S35°E, 9 lks (5.9') with pieces of rotted blaze alongside.

No trace of corner post in area of previous heavy logging.

Description of monument and accessories I established to perpetuate the original location of this corner:

At position established by record bearing and distance from recovered remnants of Sections 17/bearing tree...

Set a 2½ aluminum cap on 2½ x30 aluminum pipe 27 in ground surrounded with mound of earth & stone. Set al fence post of corner & attached sign 54-9 & 54-2.

New bearing trees have a brass washer stamped PLS 1106 nailed to face of blaze. Attached sign 54-3 & 54-9, painted face of blaze & a 6" red band around each bearing tree.
