IT FURTHER APPEARING that subsequent to acceptance of the petition on March 21, 1990, the proposed vacation was granted on April 4, 1990, in the hearing room of the Board of Commissioners in the Umatilla County Courthouse, Pendleton, Oregon; as 100% of Landowners signed the petition, notice of the time and place of the hearing was not needed, as provided by law; and finding the property proposed for vacation to have little to no value to the county, no liabilities are to incurred resulting from the vacation; and the Board of Commissioners finding that it would be in the public interest to vacate a portion of King Road in the SW1/4 of the SW1/4 of the NE1/4 of Section 21, Township 4 North, Range 28 East, Willamette Meridian, located approximately 2 1/2 miles Southwest of Hermiston, Umatilla County, Oregon hereinafter described; (legal attached)

hereby vacated and that all right and title thereto subject to the rights of all public and private utility companies or easements of record, does hereby vest in the owner of the land abutting the vacated property by extension of the person's abutting boundaries to the center of the vacated property, in accordance with Oregon law.


